1. Applicant Instructions – *Please read carefully before completing application*

- ☐ Application shall be electronically completed. **Handwritten applications or copies will not be accepted.** If necessary, explanations and continuations shall be on additional sheets of paper and should be numbered to match the application item numbers that are being explained or continued.
- ☐ Issuance of your permit will be delayed if this application is incomplete or otherwise improperly prepared. Application should be submitted to the Nebraska State Patrol **at least 45 days in advance** of the date the permit is required.
- ☐ Submission of this application **does not authorize** the applicant to engage in the requested activity. A permit must be obtained **before** operations commence.
- ☐ **New applicants are required to physically report to a Nebraska State Patrol office** (see next page for locations) to be fingerprinted, photographed, and tested.
 - New applicants **shall** make an appointment at the Nebraska State Patrol office of their choice to schedule fingerprinting, photographing, and testing.
 - At their scheduled appointment, new applicants shall present completed application and supporting documents. Copies will be taken of supporting documents, originals will be returned to applicant if applicable. The following will be required for new applicants:
 - Proof of identification:
 - State issued operator's license; *or*
 - State issued ID card; *or*
 - Current Military ID.
 - Proof of citizenship:
 - State certified Birth Certificate; *or*
 - Naturalization papers; *or*
 - Certificate of Citizenship; *or*
 - Current or expired Passport.
 - Training document(s):
 - Certificates of training; *and/or*
 - Letter from company documenting training; *and/or*
 - Explosive permits from other states; *and/or*
 - Shot logs; *and/or*
 - Justification for explosive use.
 - Include appropriate permitting fees. Make checks or money orders payable to the Nebraska State Patrol.
 - **New applicants will be required to take a written test.** Testing will be conducted during the scheduled appointment.
- ☐ The certification in Section 4 must be executed on the original application by the user/applicant.
- ☐ **Renewal or Replacement applicants do not need to be fingerprinted.** Completed applications, supporting documents, and appropriate fees shall be mailed to:
