



DNA Buccal SWAB Collection Kits


The DNA buccal SWAB collection kits with the q-tip type collector are <u>expiring</u> July 31, 2015. Please check your offices and use these kits up before they expire.

It is important to <u>always check the expiration date</u> on the back of the DNA collection kit— if it has expired, the sample will be <u>rejected</u> and you will be asked to re-collect the sample.



CODIS Prelog Option

If you have access to a computer and your NCJIS account, we ask that you please <u>use CODIS Prelog</u> to search for any previously collected sample(s) from the convicted offender, and to submit the offender information electronically. This will save <u>you</u> time as well as streamline the accessioning process at the la-

boratory.



Helpful Hint - Collection Kit Packaging/Handling

Please do NOT lick or glue the Sample or Kit envelopes!! Use the tamper resistant tape provided in the collection kit to seal the envelopes.

EasiCollect Device (Blue Plastic Sponge)


When collecting the offender's DNA sample using the EasiCollect Device (blue plastic sponge) <u>please ensure that there is a color change on the FTA card from pink to white.</u>


Samples have been submitted to the NSP Crime Laboratory (NSPCL) with no color change and, as a result these samples produce little to no DNA. Without an appropriate amount of DNA on the collection card we are unable to produce a DNA profile requiring the need for the submitting officer to re-collect the sample from the offender.

Controlled Substances Unit: Federal Grand Jury Rush Requests

Due to the backlog of cases in the controlled substances section of the crime laboratory, careful consideration must be given to the prioritization of cases so as to ensure that <u>all submitters</u> receive as timely a service as possible! The NSP Crime Laboratory (NSPCL) serves all of the state, city and county law enforcement agencies in Nebraska, federal task forces, and other state agencies with investigative and enforcement authority. The controlled substances section of the NSPCL receives approximately 3,000 assignments per calendar year and currently has a backlog of 903 assignments.



The controlled substances section analysts are responsible not only for analysis of all samples submitted to the laboratory but also for travel to and testimony in court when subpoenaed. Court testimony is routinely provided in county cases (can be across the state, including frequent trips to Scotts Bluff County) and federal cases (Lincoln, Omaha and out-of-state).

Because the NSPCL controlled substances section provides services to these varied agencies, the allocation of resources must consider all agencies equally. Therefore, the NSPCL does not ordinarily rush cases for federal grand jury indictment. The NSPCL management has conferred with John Higgins of the U.S. Attorney's Office and it was agreed that taking a case out of order solely for the purpose of rushing a case for federal grand jury indictment is typically not needed; indictment can wait for a later grand jury term. Honoring rush requests for purposes of federal indictment unfairly penalizes state and local cases that are in the backlog queue and are of equal importance. Therefore, federal grand jury cases are worked in the order they are received with all other cases from our submitting agencies

In order to request that a case be rushed, NSP form 750B must be filled out completely with information regarding the <u>reason for the rush</u> request and contact information of the person requesting the rush. Filling out the rush request form <u>does not ensure the case will be rushed</u>, it simply provides the laboratory with the information to properly evaluate the feasibility and necessity of rushing the case.

Discontinuation of Forensic Document Examination Services

In an attempt to provide the best possible services to our contributing agencies, the Nebraska State Patrol Crime Laboratory (NSPCL) constantly evaluates our laboratory analytical services in order to ensure our resources are being applied in the areas deemed <u>most</u> critical and beneficial to our stakeholders. Since 2007, we have been providing forensic document examination services through a contract agreement with a private laboratory as a temporary arrangement with the thought that we may, at some point, reinstate that service in-house.

However, at this time we have determined that re-instating forensic document examinations in-house will not be feasible and continuing to fund a service that we do not foresee offering internally is not the most efficient use of our resources. Therefore, as of <u>April 30, 2015</u>, we will no longer be facilitating forensic document examination services through our crime laboratory. New forensic document examination cases submitted to the laboratory after April 30, 2015 will be returned to the submitting agency unexamined.

New NSPCL Facility Update

The new NSPCL facility project is currently on schedule with a goal of moving in early September 2015! Many different components are involved in moving a forensic laboratory, necessitating a considerable amount of coordination. These components will unfortunately result in some casework downtime. We are working to minimize downtime as much as possible, but anticipate that there will be a period of a few weeks (perhaps longer for some disciplines) that we will be unable to accept new evidence and/or complete case work.



A portion of this downtime is due to the difficulties involved with moving sensitive laboratory instruments. Physically moving laboratory instrumentation requires involvement of the various instrument vendors from around the country to come here to pack, unpack and set up each of their instruments. In addition to the physical relocation of the NSPCL's section instrumentation, a number of tests must be completed to insure all instruments are operating properly in the new laboratory environment. Prior to the move to the new facility, analysts will be working to get as many evidence examinations completed as possible, so we can return your evidence! This is being done in order to minimize the amount of evidence that must be inventoried, secured and transported to the new facility. More detailed information will be provided as we get closer to the relocation date.

Hints on Evidence!

• Please use the most current 750 Submittal Form! The form can be located on the Nebraska State Patrol website at:

- As we near our move date to the new NSPCL facility, we are asking that all of our customers come pick up evidence in a <u>timely manner</u> once you are notified that analysis is complete. The less evidence that needs be relocated and inventoried, the less downtime will be required to get up and running.
- Sealing evidence: Please remember to **INITIAL** your taped seals on the external areas of the evidence packaging.



New DNA Laboratory Report Format

ASCLD/LAB-International (ISO) standards require that accredited laboratories gather customer feedback regarding laboratory performance and to help identify possible areas for improvement. In 2013, the NSP Crime Laboratory distributed a customer feedback survey in order to determine areas that could be improved upon within the laboratory. The results of this survey suggested that lab reports, specifically those regarding DNA testing, were difficult to understand. While this was not a big surprise, the constructive feedback provided the lab with the motivation to pursue this issue further.

The Biology Unit worked on ways to simplify the reports to make them easier for the customers to understand. This proved to be a challenge due to the inherent need to maintain the scientific integrity of the reports as well as maintaining the information required by accreditation standards. While the information in the report would remain the same, we looked for ways to increase the use of plain English when possible limiting scientific terminology and to simplify the format in which the information is presented.

The NSPCL formed a focus group covering various demographics consisting of law enforcement agency representatives, prosecutors, and defense attorneys from around the state. We felt that it was important to consider readers with both minimal and extensive experience working with DNA reports. The members of the focus group were sent four different proposed DNA report formats to review and then were interviewed by NSPCL staff. The interviews were extremely beneficial and brought to light several "easy fixes" that the laboratory staff had not considered. While not unanimous, the overwhelming report format choice was clear.

As a result of your comments/input on the 2013 customer feedback survey, as well as effort spent by the focus group, we implemented the new lab report format for Biology (DNA) cases in early 2015. Thus far, the feedback has been very positive!
