New Eye in the Sky Patrolling Nebraska

For the first time in over a decade years, the NSP Aviation Support Division has added a new aircraft to the fleet. The new helicopter is already on patrol, featuring a call sign to honor a fallen hero.

The new Bell 505 helicopter carries the call-sign Patrol373 to honor the late Trooper Jerry Smith #373, who was lost in the line of duty on 2019.

"When we were given the opportunity to choose the call-sign for the new aircraft, the choice became clear quickly," said Lt. Brian Petersen. "Many troopers serving today had the opportunity to work with or attend camp with Trooper Smith. And for those who didn't, they've certainly heard about his service both to NSP and our country."

NSP is honored to carry on Trooper Smith's badge number for many years to come with

this new helicopter.

The addition of Patrol373 adds a new level of capability to the ASD. The helicopter's primary role will be conducting operations around Nebraska's largest communities, adding additional hours of regular aerial patrol.

The new helicopter will also extend the life of service for NSP's Bell 407 helicopter by reducing the annual number of flight hours on the 17-year-old helicopter.

NSP currently has four certified helicopter pilots with Troopers Emhovich and Hinkle gaining their certification this year. Both

are currently building hours of flight time with Lt. Petersen and Trooper Strack in order to conduct solo operations.

Troopers Nicholson and Schmitt are both certified for solo flights in NSP's fixed wing aircraft and are conducting operations based in North Platte.

NSP Aircraft Mechanic Sean Case has been preparing for months to maintain the new Bell 505 and is a tremendous resource for completing inspections and maintenance in-house.



NSP Wraps-Up Busy Summer Across Nebraska



Troopers, Investigators, and professional staff were all kept busy during the summer months.

From high-profile investigations, to nationwide campaigns, to internal efforts, all aspects of NSP operations have been on display over the last several months.

The month of August was particularly busy. On August 4, troopers, investigators, and support staff from around the state sprang into action with the discovery of a quadruple homicide in Laurel, Nebraska.

Not only did NSP personnel from several troop areas travel to Laurel to assist with the investigation and the arrest of the suspect, but other personnel shifted resources to cover other areas and keep the rest of Nebraska safe.

The Laurel investigation was a massive undertaking, with two separate crime scenes that both had significant fire damage. As deputies, officers, and troopers responded, fire was still a factor and prevented

understanding the full-scope of the crime in the early hours.

Local volunteer firefighters changed their tactics in order to preserve evidence inside one of the homes, which was known to have three victims. The work done to preserve evidence led directly to a suspect, who was arrested hours later by the NSP SWAT team.

The case is still awaiting trial and incalculable hours have been spent on the investigation. In the weeks since, troopers have also made specific efforts to connect with the people of Laurel. This has been an incredible example of NSP's teamwork and dedication.

Also in August, Troopers participated in the Operation Able Vanguard, a collaboration of state police agencies from

more than two dozens states focused on criminal interdiction across the United States.

NSP finished in the top-five in terms of the amount of illegal controlled substances taken off the road during the operation. Troopers found 258 pounds of cocaine, 18 pounds of fentanyl, 180 pounds of methamphetamine, and over 140 pounds of marijuana during traffic stops in the month of August. Troopers also located multiple illegally-possessed weapons during the month. Troopers also recovered a stolen semi-trailer filled with Amazon products during the operation.

Those are just some examples of the great work performed by NSP this summer!

As we head into the last quarter of an eventful 2022, I want to take the time to thank everyone for their exceptional work on behalf of the citizens of Nebraska! In recapping this summer's activities I was both impressed and proud of the great work being done across the agency. In our Crime Lab, our recent additions in Biology have really cut into our backlog. Once our new scientists were fully trained, they hit the ground running, and the results speak for themselves. Speaking of Crime Lab, the team is working hard with DAS to prepare for the new addition to be built which will add much needed capacity to our lab. We are looking to break ground next summer if all goes well.

A complex and rare case emerged in Laurel on August 4-5 that required resources from across the agency. A rare quadruple homicide involving arson taxed our investigators as well as

the initial responders to this event. The teamwork from uniformed, investigative, and civilian personnel was simply outstanding. While this case is still ongoing, I think it bears mentioning due to the great work and the unusual nature of the case.

We also recently concluded the Nebraska State Fair and Husker Harvest Days. A special shout out to Troop C personnel who handled the majority of the work with assists from across the state.

In addition to these normal summer events, we worked what seemed like endless overtime in construction zones along with permit moves and other smaller events. Everyone stepped up to fill the various needs, despite our shortage of staff. Speaking of staffing, our DUI arrests, felony arrests, and overall activity continues to climb, even though we closed August with 66 vacancies in sworn staffing. Our civilian staffing continues to lag behind

our needs as well. In short, we are doing just as much quality work with fewer people than we ever have. For that I must say a well-earned THANK YOU to everyone in NSP. Thanks for a great summer, and enjoy the rest of 2022!

Around the State

Troop A

Troop A has been busy with ongoing construction projects all over the Omaha metro area.

Troopers have assisted in working construction speed selectives to try and reduce accidents in these areas. Troop A Patrol and Investigative Services unit has also assisted in working DDACT selectives with the Omaha Police Department in high-crime areas to assist in violent crime and gang suppression. While working these selectives, troopers assisted OPD with taking guns, drugs, and multiple violent offenders off the streets and this will continue to be a priority as we

move forward. Troop A Traffic also worked several reckless driving selectives with the assistance of NSP Airwing and OPD Able One. These selectives focused on vehicles driving recklessly with the intent to evade law enforcement. Multiple drivers were arrested for felony traffic violations and multiple citations for speeding and reckless driving.

Troop A's Investigative Service Unit has been busy with criminal and drug investigations through TFO partnerships with our local and federal allied agencies. The Commercial Interdiction Unit (CIU), Tactical Diversion Squad (TDS), and

others have worked on multiple cases and investigations that lead to many dangerous criminals being arrested and numerous dangerous drugs taken off the streets making communities in the troop area safer, but also making communities around the US safer.



Troop B

Troop B had a busy third quarter!

In addition to the Laurel homicide investigation, Troop B ISO began investigating a shooting death that occurred in rural Wayne County in September. The Wayne County Sheriff's Office initially responded to the incident that night around 7:15 p.m. Upon arrival, deputies located a male victim with a gunshot wound. He was transported to the hospital where he was pronounced deceased. Nebraska

State Patrol lead the investigation and discovered a marijuana grow operation on the property. Two individuals were identified and arrested on charges related to the grow operation. The homicide investigation remains ongoing.

Troopers also arrested two people after a rare find in a field. Troopers found over 20 pounds of suspected methamphetamine buried in a field during an investigation near Winside. A resident of rural Winside reported two suspi-

cious individuals going through their property. Troopers responded and contacted both individuals. Troopers discovered that both individuals were in possession of suspected methamphetamine. As the investigation continued, troopers developed information that a large quantity of methamphetamine had been buried in the field near by. Troopers searched the area and located additional methamphetamine and fentanyl. Both individuals were lodged in Antelope County Jail.



Troop C

The third quarter in Troop C means hosting the Nebraska State Fair!

Troopers from every division are brought in from around the entire state to represent our agency and ensure the safety of all fair

attendees. The success of this event is a direct result of the dedication and sacrifice from all of our troopers. There is considerable effort put forward by our troop areas and families so we can do our part to make sure FFA, vendors, exhibitors, concerts and everyone attend-

ing those events can do so in a safe environment. The interactions we have with the citizens of Nebraska and beyond does not go unnoticed and is greatly appreciated.

A week after the State Fair, Troop C hosts the world's largest totally irrigated working farm show for three days, Husker Harvest Days. There are always challenges getting people from across the country onto a small amount of farm ground.

A lot of hours planning and even more hours working the event meant another safe and successful year for the farming community and law enforcement.



NSP Hosts National USEOW in Omaha

In July, troopers from around the United States traveled to Omaha to participate in the annual USEOW (Uniformed Safety Education Officers Workshop). This annual conference hasn't been held since 2019 because of COVID, but came back to Nebraska, where USEOW began in 1968, to kickstart it again.

Troopers from 14 states attended this year's USEOW, which came together after many months of planning.

During the workshop, troopers gave safety presentations to each other, as if their audience was at a school or community event. Each state is then encouraged to take those presentations home to adapt for their own communities.

At the end of the conference, troopers vote on which states gave the best presentations and awards are presented at a closing banquet. This year, NSP's Trooper Tim Flick received the 2nd place award in the Public Safety Presentation category!

At the conclusion of the event, Nebraska passed the torch to South Carolina, which will host the 2023 USEOW.

Thanks for Troopers Okamoto, Chase, Bell, Cook, Flick, and many others for their work to make this constructive event happen!



Troop D

Troop D has been successful this past quarter with the interdiction of 220 lbs. of cocaine located on one stop. Another traffic stop was developed to allow the deployment of our Viken backscatter x-ray device. A scan of two decorative styrofoam corbels yielded 101 lbs. of methamphetamine and 9 lbs. of fentanyl. Most of the criminal interdiction effort has been made possible with HIDTA grant funds.

The interest in interdiction was revived with a selective at the North Platte Scales in

January 2022. Troopers from other Troop Areas had focused on CMV's. It has since developed into focused efforts along I-80 and arterial Highways. Troopers have taken it upon themselves to apply for grant funds and organize teams to support each other from initial traffic stops to processing evidence. The teamwork allows for a greater presence along our Interstate.

Troopers and Investigators have been busy keeping up community relations. Topics on Human Trafficking, Drugs, and

Safe Driving have been discussed in the area schools. The practical exercises for mass casualty events have taken place on tabletop and in live settings. Phelps Memorial, Emergency Management, and other first responders have held the largest event thus far in the area. Such exercises test interoperability.



Troop E

Troop E has had a busy 3rd quarter!

On Saturday, July 30, 2022, NSP Personnel assisted with Cedar Canyon Wildfire. Our troopers assisted with notifications, evacuations, and closing of roads to assist fire personnel. 13,000 acres were burned from this wildfire.

The US Marshall's, Scottsbluff County Sheriff's Office and NSP Patrol and Investigative Services Division conducted a SOR compliance check in

Scottsbluff County. 127 SOR packets were complied for checking. 102 of the SOR's were fully compliant. One physical arrest was made due to non-compliance and several

reports are being forwarded to the Scottsbluff County Attorney regarding various violations of the SOR registration.



Troop H

The HDQ Patrol Division is responsible for 14 counties in southeastern Nebraska and our troopers are stationed throughout. We have troopers in Lincoln, David City, Wahoo, Beatrice, Fairbury, Geneva, and Nebraska City. HDQ is a young troop area with over half of our troopers having five years or less in the agency.

We remain committed to the citizens of Nebraska and have had a very productive third quarter. HDQ Troopers have arrested 86 impaired drivers this quarter, which is up nearly 26% from second quarter. Our drug citations have increased 9% to 138. Our alcohol citations have risen as well nearly 18%, since second quarter.

HDQ Troop lost one of our best in July with Trp. Kent Kavan retiring after having served the State of Nebraska for 35 years! Kent's retirement coffee in Lincoln had an amazing turnout and was attended by NSP members from all over the state. Kent's experience and wealth of Knowledge will be truly missed.



This quarter we had four troopers attend The Street Smart Cop/Pro-Active Patrol Tactics class in St. Paul, Minnesota. Troopers Ben Nguyen, Ty Schoenefeld, Nate Knudson, and Ethan Schroeder attended this one day class which focused on state and federal case law, sharpening current skills, as well as recognizing criminal behaviors and trends.

Finally, we wrapped-up the third quarter by hosting three consecutive Husker home football games in September. Husker home games can create some of the busiest Interstate traffic of the year for our road troopers with thousands of people coming into Lincoln.

With the help of our Aviation Support Division and partners at NDOT, we have had a safe football season thus far.

Our Troopers are not only out patrolling on game days, but are also inside of Memorial Stadium providing stadium security. This season NSP has increased the number of uniform Troopers inside the stadium and have been averaging nearly 20 Troopers per game.



Carrier Enforcement

The Carrier Enforcement Division was responsible for the safe movement of 13 dual lane moves throughout the state. NSP works closely with NDOT to coordinate and execute movement of these extremely large and heavy loads in the overnight hours to reduce the impact on motorists. It is common for these loads to weigh in excess of 500,000lbs and be 20 feet or more in width.



The NSP Carrier Enforcement Division completed a series of training sessions which offered instruction in multiple disciplines of commercial vehicle inspections.

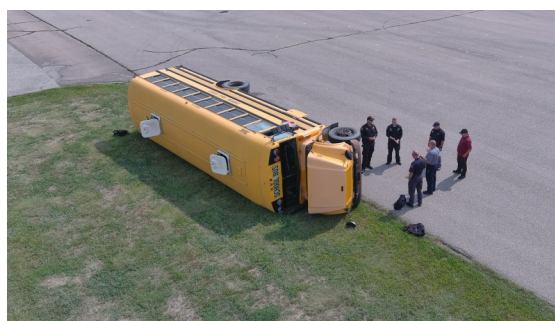
"We were proud to host dozens of troopers and officers from other states as they work to gain skills to better serve their communities," said Captain Martin Denton, Commander of NSP Carrier Enforcement. "Traffic safety is a partnership that crosses state lines and our team is always willing to share knowledge and skills with other agencies."

NSP hosted training sessions at the NSP Training Academy in Grand Island. Troopers from 14 state law enforcement agencies, officers from several other agencies, and representatives from the Commercial Vehicle Safety Alliance all participated in the training.

"This class was modeled on what our troopers were seeing in the field," said Captain Denton. "Post-crash inspections are critical in criminal cases and other crash investigations. This program was a perfect opportunity to not only fine-tune our internal training, but also share

techniques and training with many other agencies. We're all working together to make roads safer."

The training sessions provided both classroom and hands-on instruction in areas of forensic examination of commercial motor vehicles as well as completion of post-crash inspections of commercial motor vehicles. Participants conducted five different advanced Level-I post-crash inspections throughout the week of training.



Featured Divisions: Accounting and Crime Lab

Accounting

September 15th marked the completion of NSP's two year-budget request submission. Multiple meetings were held by the Accounting and NSP leadership to fully vet needed budget increases for the new biennium. Additionally, meetings were held with the Governor's budget office to reach an agreement regarding which items would be submitted. The next step in the process is the Governor's publication of his statewide budget recommendations for the Legislature to review. This is then followed up by the Legislature's Appropriations Committee reviewing all of the state budget requests and the Governor's recommendations, making decisions about budgetary approvals, and crafting the budget bill that will be voted on in the spring of 2023. The new budget then goes into effect on 7/1/23 and remains in place until 6/30/25.

Another recent Accounting related development impacting the agency is the passing of LB 964 which allows NSP employees to receive 100% of the GSA per diem amount for

meals while in travel status. This is a welcomed change for the agency. New Employee Reimbursement forms will be published for the submission of expenses to ensure the correct rates are reimbursed to the employee.

The NSP Grants team has been busy with new grant applications for the new Fiscal year. Since the end of April, the grant division has applied for 9 Federal grants to support programs, divisions and equipment at the NSP. The total amount requested with these grants is \$7,396,884. Some of these grants are still pending approval at the federal level. In addition, we have applied for one special solicitation with the Crime Commission for Leeds License support. We also applied for and were awarded 2 project grants for Tracs and Toxicology from the Highway Safety office for FY23.

Ongoing grant activity includes Task Force MOU's, Highway Safety Office mini grants for the Total Station equipment and training, traffic enforce-

ment, compliance enforcement, Husker game day traffic enforcement and select construction zones across the state. HIDTA also awarded NSP grant funding for FY23 to provide ongoing support for programs.

The NSP Grants division has supported The NSP Foundation for many years. However, in June of this year, the Foundation voted to take over their own business affairs. The transition from NSP Grants to the Foundation occurred in August. Therefore, the Grants division is no longer involved in the ongoing administrative and financial functions for the Foundation. This administrative change does not impact the funding that remains available from the Foundation for approved projects. A procedural guide has been created and is available to the field to assist them in any process changes for requesting funding.

Crime Lab

Since moving to its current facility in 2015, the NSP Crime Laboratory has grown from 25 staff members to 41 in an effort to keep up with the increasing number of cases, constantly changing testing methods, and increasingly complicated sample types being submitted to the lab. The facility has now exceeded capacity. Recognizing this critical overcrowding problem, last session the legislature appropriated funds for expansion of the lab facility to ac-

commodate current needs as well as anticipated growth for several years. In partnership with the Department of Administrative Services and State Building Division, NSP is now in the process of selecting a design team to plan the facility expansion, which will approximately double the size of the building. While maintaining a fully operational lab during the construction phase will be challenging, this exciting multi-year project will ultimately allow for

growth in personnel and testing instrumentation, as well as greater efficiency, thereby enabling us to provide more timely services to our customers.

Camp 66

Nineteen recruits began the journey to being a Nebraska State Trooper in July at the NSP Training Academy. Sixteen of those recruits remain at the TA and are more than halfway through the program.

The recruits have spent their time learning the culture of the Nebraska State Patrol, gaining academic knowledge and skills, and starting to train on the work that will be required of them once they graduate and hit the road on patrol.

Although COVID has still been an issue, the group is still staying busy and working hard to stay healthy and complete the training.

Some examples of the training that the recruits go through

are Building Search/Active Threat, Patrolling, Practicing Drug Recognition, Accident Investigation and many other training courses as their training goes on.

Camp 66 is scheduled to graduate on December 16, 2022.



The gained skills and knowledge coupled with the relationships built really prepare recruits for a successful career with the Nebraska State Patrol.

Intern Spotlight

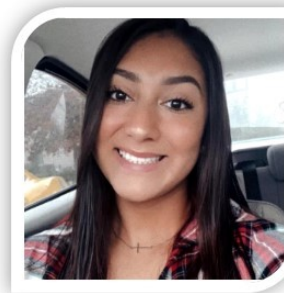

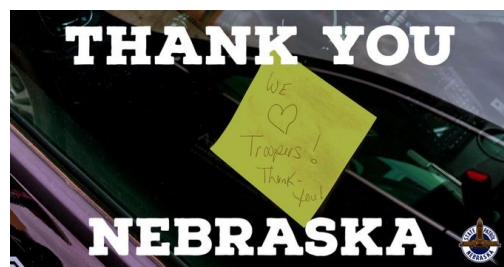
